The undersigned recognizes that there is an element of risk in any hunt, adventure, sport or activity associated with the great outdoors, and specifically assumes all risks and liability therein, pursuant to the Wyoming Recreation Safety Act [W.S.1-1-122,123], and is fully capable of participating in the above listed indoor/outdoor activity, hunt or trip. Therefore, holding harmless, Bridger Wilderness Outfitters, LLC, their agents, employees and/or landowner lessors, releasing them from all liabilities. Furthermore, the undersigned has read and fully understands and accepts the above terms and conditions of this contract and willingly agrees to execute this contract by signing below, at his or her free will.

An initial, non-refundable deposit/payment of \$1,000.00 is required to reserve your hunt. A second payment totaling approximately 50% of the value of the hunt booked, plus WGFD License fees, will be due on or before January 1st, the year of your hunt. The final payment on your hunt will be due in full by August 15th. All reservations made after the WGFD draw will require a 50% deposit/payment at time of booking, with final payment due in full by August 15th.

Personal or certified checks, money orders or credit cards are acceptable for all payments to Bridger Wilderness Outfitters. A transaction fee of 4% will be added to all credit card payments. State and County sales and lodging taxes of 11% will be charged on meals and lodging only. No reservation is confirmed until Bridger Wilderness Outfitters has received a full 50% deposit, completed booking contract, liability release and health & dietary questionnaire. All Hunt Reservation Deposits/Payments are non-refundable after January 1st, of the year the hunt is booked for, unless the booked guest can furnish Bridger Wilderness Outfitters with an acceptable substitute for themselves. Beyond these terms, only upon failure to draw a license will any deposit/payment be returned, within 30 business days of the WGFD on-line drawing results. Withdrawn license applications do not constitute a failure to draw a license. We can make no refunds or adjustments for late arrivals, early departures, no-shows or late hunt cancellations. Likewise, the full contracted hunt fee is the responsibility of the booked client and owed to the outfitter regardless of the client's participation in his or her booked hunt. Deposit/payments and/or licenses are not transferable to another person.
